- ALL quilts must have a 4" to 6" sleeve (except for miniatures). No quilt will be accepted without a sleeve.
- Complete and submit the application by **March 19, 2010**. Submit a color photos (4" X 6") for **each quilt entry**. The photos are for identification purposes and to help us plan a more color and theme coordinated show.
- Complete an application and submit a **\$10 application fee** for **each quilt entry**. **Make checks payable to Rivers & Spires. Mail to the Rivers & Spires, 25 Jefferson Street, Suite 300, Clarksville, TN 37040.**

Local Entries:

- Quilt drop off--**Madison Street United Methodist Church, 319 Madison St., Clarksville, Tennessee (Commerce Street entrance).**
- Drop off date / time—**Tuesday April 13th between 3 and 7 PM.**
- When dropping off your quilt you will be given a numbered receipt for each item. **For security purposes**, this receipt will be required to pick up your quilts. If someone other than yourself will be picking up your quilts, please advise the quilt show committee at time of drop off with the name of the pick-up person.
- Quilt pick-up –**Sunday April 18th at the Madison Street United Methodist Church, 319 Madison St. (Commerce Street entrance), between the hours of 2 and 4 PM.**
